

IBEW Bargaining Unit Employees - CBA Art XI Application for Educational Assistance Program

Per the Collective Bargaining Agreement, employees, who, on their own initiative, successfully complete a course or courses approved in advance by the Authority as being related to their job classification or at a level to improve their abilities and qualifications for advancement within the Authority, shall be reimbursed not to exceed five thousand (\$5,000) per year for courses approved in advance by the Authority for ninety percent (90%) of their necessary expenditures for books and tuition related to such course our courses. The Authority shall reimburse an employee upon evidence of satisfactory completion of each phase of the approved program.
