

Introduction

This Report to the Governor and Legislative Leaders on the Recharge New York Power Program (“Report”) is submitted by the Economic Development Power Allocation Board (“EDPAB”) and the Power Authority of the State of New York (“Authority” or “NYPA”) pursuant to Economic Development Law § 188-a(h)(1), which provides:

The board, in consultation with the authority, shall submit to the governor, temporary president of the senate, speaker of the assembly, minority leader of the senate and minority leader of the assembly an evaluation of the effectiveness of the recharge New York power program. Such evaluation shall focus on how the program has aided recipients of power allocations, and may include recommendations for how the program can be made more effective, and shall be based, in part, on the relative costs of power for recipients in comparison to the cost of power for non-recipients. Such evaluation shall be submitted by December thirty-first, two thousand fifteen and by December thirty-first every five years thereafter.

ReCharge New York Power Program

On April 14, 2011, Governor Andrew M. Cuomo signed into law Chapter 60 (Part CC) of the Laws of 2011 (“Chapter 60”) which created the Recharge New (“RNY”) Power Program. The primary statutory provisions relating to the RNY Power Program are codified in Economic Development Law (“EDL”) § 188-a and Public Authorities Law § 1005(13-a). The RNY Power Program replaced the Power for Jobs (“PFJ”) and related programs to provide a more effective incentive for businesses to create jobs and make long term capital investments in New York State.

The RNY Power Program is a state-wide economic development power program that consists of 910 megawatts (“MW”) of “RNY Power,” 50% of which is made available from the hydropower resources of the New York Power Authority (“NYPA”) (“RNY hydropower”), and 50% of which is provided by NYPA from other sources, which may include purchased power, power from NYPA sources (other than the Niagara and Saint Lawrence projects), or other sources (collectively “RNY market power”).

The RNY Power Program is administered by NYPA and the Economic Development Power Allocation Board (“EDPAB”). Pursuant to Chapter 60, NYPA provides staff services to support EDPAB’s functions. RNY Power is available to large businesses, small businesses and not-for-profit corporations for job retention, business expansion and business attraction purposes. Chapter

60 provides that (1) at least 350 MW of RNY Power be dedicated to facilities in the service territories served by the New York State Electric and Gas, National Grid and Rochester Gas and Electric utility companies; (2) at least 200 MW of RNY Power be dedicated to the purpose of attracting new businesses and encouraging expansion of existing businesses statewide; and (3) no more than 100 MW be dedicated to not-for-profit corporations and small businesses statewide.

Under the Program, “eligible applicant” is defined to mean an eligible business, eligible small business, or eligible not-for-profit corporation, however, an eligible applicant does not include retail businesses as defined by EDPAB, including, without limitation, sports venues, gaming or entertainment-related establishments or places of overnight accommodations. EDPAB has defined a retail business as a business that is primarily used in making retail sales of goods or services to customers who personally visit such facilities to obtain goods or services.

As part of the contractual agreement for the sale of RNY Power, each customer agrees to retain and/or create jobs, invest future capital in the facility, utilize the power allocated and conduct an energy efficiency audit at the facility using the RNY Power allocation within the first five years of the seven-year contract term.

RNY Power allocations pertaining to new program participants have been awarded by the NYPA Trustees on thirty occasions from April 2012 through December 2020. Beginning in July 2017, existing customers could apply for a 7-year extension to their existing RNY allocations. In total, RNY Power allocation extensions have been awarded by the Trustees on ten occasions from October 2018 to December 2020. To date, nearly 340 RNY Power allocation extensions have been approved by the Trustees supporting more than 275,000 jobs and \$10.1 billion in capital investment commitments.

In response to the COVID-19 pandemic, the NYPA Trustees in March 2020, approved the Economic Development Customer Assistance Program (“EDCAP”) under which eligible RNY Power customers could defer payment of monthly NYPA billed energy and demand invoices for a period of up to six (6) months (from April 2020-August 2020) without interest or penalty. Deferred amounts will be recovered over an eighteen (18) month period beginning with the September 2020 billing period. Nearly 300 RNY customers are currently participating in this program.

To provide further assistance to NYPA business customers, in December 2020 the Trustees approved an additional


benefit under EDCAP known as Temporary Power Assistance (“TPA”). Under TPA, RNY Power customers were invited to apply for additional RNY Power to serve load not currently served by NYPA. The initial round of TPA allocation recommendations was approved in December 2020.

RNY Power Program Administration

The RNY Power allocation process commences with the filing of an application for both new and extension applicants. The application for RNY Power has been incorporated into the State’s on-line Consolidated Funding Application (“CFA”) and made available to applicants beginning in September 2011.

RNY Power applications are reviewed by NYPA staff and presented to EDPAB for eligibility determinations. If an applicant is deemed eligible, EDPAB evaluates the application on the merits based in statutory criteria which include the following:

1. The significance of electricity costs to the applicant;
2. The extent to which a RNY award would result in new capital investments in the State;
3. The extent to which a RNY allocation is consistent with any regional economic development council strategies and priorities;
4. The types of facilities the applicant proposes to construct, enlarge, or install in consideration for a RNY allocation;
5. The payroll, salaries and benefits provided by the applicant;
6. The number of jobs the applicant would create or retain in relation to the size of the RNY allocation requested;
7. The risk the applicant would leave the State, curtail operations, or eliminate jobs without the RNY allocation;
8. The significance of the applicant’s facilities to the local economy;

9. The extent to which the applicant has invested in energy efficiency measures, will agree to make tangible investments in energy efficiency measures or participate in energy audits of its facilities;
10. Whether the applicant receives a hydroelectric power allocation or benefits supported by the sale of hydroelectric power under another program administered in whole or part by NYPA;
11. The extent to which a power allocation will result in an advantage as compared to its competitors in the State; and
12. Regarding not-for-profit corporation applicants, whether the applicant provides critical services or substantial benefits to the local community.

The NYPA Trustees make final award decisions after considering EDPAB’s recommendations and the statutory criteria.

In December 2020, the NYPA Trustees authorized the implementation of a “green jobs” incentive plan for NYPA’s economic development power programs which businesses under NYPA’s power programs may receive enhanced scoring for the creation and retention of green jobs. The green jobs evaluation will be applied prospectively to new program participants who apply for RNY Power to support new load, as well as to retention-based load that is not

currently served by the Authority. The green jobs incentive plan supports the Authority's 2030 Strategic Plan, which encourages the promotion of the clean energy sector.

NYPA and EDPAB also receive input on applications from the relevant State Regional Economic Development Councils ("REDCs") for the region where an applicant's facilities are or will be located. REDCs were established by Governor Cuomo in 2011 to develop long-term strategic priorities and plans for economic growth in their respective regions and are denoted in the map on page 5.

RNY Power Contract Process

To promote long-term business commitments to the State, new and extended RNY Power allocations ("Awarded Allocations") are offered for a term of up to seven years. Each Awarded Allocation consists of equal parts RNY Hydropower and RNY Market Power. To help accommodate the energy needs of new RNY Power awardees, each recipient is given the option to purchase its entire Awarded Allocation (50% RNY Hydropower and 50% RNY Market Power) or the RNY Hydropower portion of the Awarded Allocation.

The terms and conditions applicable to the sale of the portion of the Awarded Allocation the customer decides to purchase ("Accepted Allocation") is set forth in a contract between NYPA and the customer ("RNY Contract"). The RNY Contract also includes provisions requiring annual reporting on compliance with contractual commitments relating to such matters as employment, capital investments and power utilization ("Supplemental Commitments"); authorizing periodic audits by NYPA to assess compliance with Supplemental Commitments; and providing for the partial or complete withdrawal of RNY Power in the event of noncompliance with Supplemental Commitments. NYPA also conducts an annual compliance verification regarding Supplemental Commitments.

RNY Power Awards and Availability

Figure 1 provides a breakdown of the current RNY power allocations Statewide. The enactment establishing the ReCharge New York Power program contains provisions indicating the purposes for which RNY Power should be allocated under the program, specifically for expansion power, not-for-profit and small business allotments. There

is an additional legislative mandate requiring that at least 350 MW of the 910 MW of RNY Power be dedicated to facilities in the service territories served by the New York State Electric and Gas, National Grid and Rochester Gas and Electric utility companies. Currently, 590.9 MW of the total 898.7 MW of RNY Power allocated have been awarded in these service territories.

As of December 31, 2020, a total of 898.7 MW of RNY Power has been allocated to eligible businesses across the State. This consists of 967 allocations awarded to 672 customers, including 94 not-for-profit corporations and 578 small and large businesses. Small businesses have a typical monthly electric demand at or below 400 kW and large businesses above 400 kW. A listing of current RNY Power awards, including recipient name, location, region, amount of power awarded, length of current Accepted Allocation and the number of jobs associated with these allocations is found in Appendix I to this Report.

As of December 31, 2020¹, the RNY Power Program had a balance of 11.3 MW of power available for allocation. This consists of 4.8 MW for large business retention, 3.6 MW for large business expansion, and 2.9 MW for eligible small businesses and not-for-profit corporations.



NYPA's annual compliance review process may result in the recapture of RNY Power where RNY Power recipients have failed to meet their contractual commitments relating to job, capital investment, and power usage.

¹This amount of unallocated RNY Power may not be available to all eligible applicants. The underlying statute specifies set-asides and caps on the amount of RNY Power that may be allocated for purposes of business retention and expansion, and certain categories of eligible applicants (e.g., not-for-profit corporations). See Economic Development Law § 188-a(c) (4).

For the prior year's (2018-19) reporting period, RNY Power customers reported over 415,000 jobs throughout the state which equated to 123% of total jobs committed by customers under the RNY Contracts. For the prior year's (2018-19) reporting period, RNY Power customers reported a five-year cumulative capital spending amount of \$35.9 billion which represented 154% of total capital investment committed.

Each year NYPA participates in regional workshops administered by Empire State Development through the CFA funding process, informing the communities of the aspects of the RNY Power Program in public sessions. In 2020, the CFA funding process was put on hold and the CFA workshops were not held considering the COVID-19 pandemic.

Figure 2 below provides a detailed breakdown of RNY Power allocations across the 10 regions, showing job creation and retention along with capital investment

commitments. The total number of customers include large business retention, large business expansion, and small business and not-for-profit entities.

Effectiveness of the RNY Power Program

The effectiveness of the RNY Power Program can be assessed by considering two primary benefits of the program: (1) reduced electricity costs for recipients of RNY Power allocations; and (2) positive economic development impacts for the State, including job retention and job creation and capital investment.

Estimated Electricity Cost Benefits

All RNY customers receive a delivery discount which is not generally available to other electricity consumers in the State. The delivery discount is derived from exempting the RNY Power costs from the State's Renewable Portfolio Standard surcharge, the Systems Benefit Charge, and the Energy Efficiency Portfolio Standards surcharge. The delivery discount applies to the recipient's total RNY Power allocation even if the RNY Power recipient chooses to purchase only the RNY Hydropower portion of its award from NYPA.

Additional factors affecting the benefit to an RNY Power customer could include:

- Selection of hydropower-only customers vs. blended allocation customers. Some customers have sufficient resources or sizable load to allow them access to potentially less costly or more price-predictable energy sources than market power. To maximize the benefit to those customers, the option to elect hydropower-only (vs. blended power) is available to RNY allocation recipients.
- Commodity cost for the power if purchased from the investor-owned utility instead of at the RNY Power rate.
- Tariff considerations including size of customer load and eligible delivery class.
- Customer operating characteristics such as load factor and voltage level.

The estimated cost benefit for each participant is based on a comparison of the cost of RNY Power vs. the local utility standard electric tariff rates. The cost of RNY Power reflects commodity and delivery costs. An estimate was developed for the cost of purchase and delivery of an equivalent amount of power from each customer's local utility at the standard tariff rate. The difference between these two values represents the 2019 estimated benefits. These benefits were provided and communicated to customers enrolled in RNY during the 2019 calendar year.

In 2019, RNY Power collectively provided program participants statewide a total cost benefit of 16% statewide or nearly \$37.3 million, factoring in both electric commodity and delivery benefits.

Figure 3 below indicates the total estimated cost benefits in each of the 10 NYS Economic Development Regions.

Job Retention and Creation

In addition to providing benefits to RNY Power recipients, the RNY Power Program provides benefits to New York State by supporting the retention of existing jobs and the creation of new jobs. This benefit comes in the form of contractual commitments by RNY Power Recipients to (i) retain jobs, (ii) create jobs, or (iii) both retain and create jobs, in exchange for RNY Power. Currently, the RNY Power Program is supporting commitments for the retention and creation of over 370,000 jobs in New York State.

Figure 4 below demonstrates the number of jobs supported by RNY Power allocations, including extensions, in each of the 10 NYS regions as of December 31, 2020. Given that applicants may have more than one RNY Power allocation (e.g., to support job retention and job creation, respectively), the numbers of allocations and number of customers are broken down below.

Capital Investment Commitments

The RNY Power Program also supports capital investment in New York State. This benefit comes in the form of contractual commitments by RNY Power recipients to make long-term investments in the facilities using the RNY Power allocations. Customers commit to make these investments within the first five years of their seven-year contract.

Since the program's inception, nearly \$45 billion in capital investments have been reported as spent by RNY Power customers. Statewide capital investment commitments supported by the RNY Power Program currently total nearly \$19.2 billion as detailed below in **Figure 5**.

Industries Supported by RNY Power Allocations

The RNY Power Program supports many major industries throughout the state. These industries are defined and tracked as designated by the North American Industry Classification System (NAICS). The manufacturing classification constitutes the majority of RNY allocated power at nearly 71%. The Health Care and Social Assistance sector supports most of the jobs within RNY at more than 167,000, or more than 45% of the program's total.

Other predominant sectors served by the RNY Power Program include educational services, information, wholesale trade, transportation and warehousing, and professional, scientific, and technical services.

Summary

The RNY Power Program has successfully accomplished its intended goal of introducing a state-wide, power-based program that effectively supports the retention and creation of jobs and long-term capital investment throughout New York State. As of December 31, 2020, the RNY Power Program is supporting (1) the retention of approximately 362,000 jobs, (2) the creation of approximately 8,000 jobs, (3) capital spending of nearly \$19.2 billion, and (4) cost benefits which equated to nearly \$37.3 million in 2019.

EDPAB and NYPA are committed to continue the benefit that the RNY Program serves as an effective economic development tool to keep businesses in New York State, encourage existing businesses to expand their operations, and attract new businesses to foster economic growth.

Most recently, as a result of the COVID-19 pandemic, EDPAB and NYPA are pleased to further support customers at this difficult time through its Economic Development Customer Assistance Program. EDPAB and NYPA look forward to continuing and building upon the success of the RNY Power Program for many years to come.
